IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 27, 2022

To designate the park subsection of Francis Field, bounded on the east by 25th Street, N.W., on the west by the fence surrounding the athletic field, on the north by the concrete walkway into the athletic field's north gate, and on the south by the loading dock driveway for the building located at 2501 M Street, N.W., as Rebecca Coder Park.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Rebecca Coder Park Designation Act of 2022".

Sec. 2. Pursuant to sections 401 and 402 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Official Code §§ 9-204.01 and 9-204.02), the Council designates the park subsection of Francis Field, bounded on the east by 25th Street, N.W., on the west by the fence surrounding the athletic field, on the north by the concrete walkway into the athletic field's north gate, and on the south by the loading dock driveway for the building located at 2501 M Street, N.W., as depicted in the plat in the committee report, as "Rebecca Coder Park".

Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 4a of the General Legislative Procedures Act of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
